We are Ep Dent Ltd, a private limited company incorporated in England. Our company number is 09336427 and our registered address is 173 Kentish Town Road, Kentish Town London, NW1 8PD.

We are committed to ensuring that your privacy is protected. We will continue to comply with the provisions of the Data Protection Act (“**DPA**”) until 25 May 2018, after which we will comply with the General Data Protection Regulation ((EU) 2016/679) (“**GDPR**”) unless and until the GDPR is no longer directly applicable in the UK, together with any national implementing laws, regulations and secondary legislation as amended or updated from time to time in the UK, and any successor legislation to the GDPR and the DPA (together “**Data Protection Legislation**”). We are the data controller of data you pass to us pursuant to this policy.

Time period of the storage of the concerned data:

Health data:

- Medical documentation has to be preserved at least for thirty years from the time of the data recording, final report has to be preserved at least for fifty years. If no further storage is reasoned, the storage has to be annulled.
- Image recordings made with imaging diagnostic processes (e.g. X-ray, CT scan) have to be preserved for ten years from the time of the recording, medical records based on these have to be preserved for thirty years from the time of the image recording. If no further storage is reasoned, the storage has to be annulled.

Personal data:

- Invoices are preserved for at least eight years due to legal obligations. Documents on which invoices are based are preserved for eight years.
- Contact data are preserved for one year from the time of the termination of the contact.
- Data which are in connection with the fulfilment of contracts are preserved for five years.
